I also have responsibility for guiding an assistant psychologist. This was initially a 3-month contract and was extended to 6 months

#### Dec 2013 - April 2014 Locum Consultant Clinical Psychologist

#### The Priory Hospital, Southampton

As the Priory's only Clinical Psychologist, I had responsibility for assessing and treating young people aged between 13 and 17 years, who presented with a variety of psychopathology ranging (but not limited to) psychosis, self—harm, eating disorders and trauma resulting from abuse. I facilitated individual and group therapy programmes including DBT, psychoeducation, anger and anxiety management. My approach was necessarily integrative with a strong focus on CBT and cognitive mindfulness. I was also involved in family therapy on a weekly basis. I lead and advised MDT colleagues including medical professionals, Soical Workers and Occupational Therapiss and developed a policy of having nursing staff act as co-therapists in individual therapists (with clients' permission). This initiatve was to teach staff as well as to include them in sessions in order to foster a strong team dynamic. I also contributed to CPA meetings, initiated a behavioural reward ceremony for achievement and performance and participated in monthly clinical superivision.

#### June 2010 – July 2011 Locum Clinical Psychologist

#### **Dudley and Walsall NHS Trust**

I worked in an NHS Clinical Health Speciality, delivering Assessment and Therapy to individuals whose primary difficulties were related to physical disorders I also provided clinical supervision and training to colleagues as required.

I was responsible for providing Parental Capacity Assessments and therapy in the context of Looked After Children. This culminated in submission of Court reports providing expert opinion based on psychometric testing and clinical observation, liaising with social workers, solicitors and outside agencies. I also managed and supported more junior Psychologists within the service and provided Consultation to MDT colleagues.

I had responsibility for the development and provision of psychological services to inpatients at a specialist Autistic Spectrum Condition hospital. In my capacity as member of the Senior Management Team I organised and chaired Clinical Governance Case Conferences, initiated systems such as Critical Incident Debriefing and developed a culture-shift toward staff reward for achievements with challenging clinical cases. I was consulted by other Heads of Departments on issues relating to the Care Quality Commission and led the supervision of psychologists within the hospital.

#### Feb 2009 - April 2009Locum Consultant Clinical Psychologist

#### CygnetHospital, Stevenage

I combined clinical and managerial roles to lead an established therapies department within a medium - low secure forensic hospital. The post involved strategic, managerial and

supervisory functions for the psychology, occupational and arts therapies and social work professionals. In addition I held my own clinical caseload of individuals presenting with severe and enduring mental health problems, personality disorder and risk behaviours.

#### Sep 2008 – Feb 2009 Locum Consultant Clinical Psychologist

#### The Ministry of Defence (British Forces, UK)

This post involved psychological assessment and treatment of serving personnel, training and supervision of mental health professionals, provision of consultation and advice to the military chain of command and MDT management. The post was split between two Garrisons, in each of which I steered the development of service initiatives such as peer support groups and management liaison meetings. As in Germany (see below), much of my clinical work involved the psychological treatment of post-traumatic stress resulting from operational tours. Psychometric and risk assessment was a significant feature that was used to assist in occupational screening for troops both pre and post deployment.

#### July - Sep 2008 Locum Consultant Clinical Psychologist

#### The Isle of Man Department of Health and Social Security

This was an adult mental health outpatient post based in Douglas where prior to my arrival, the waiting period for a Clinical Psychology appointment was one year. I reduced this to eight months by introducing triage screening and taking on a substantial clinical caseload. I was also involved in teaching, promotional outreach and clinical supervision. Clients' presenting problems were various and included substance misuse, psychosis, relationship difficulties and trauma following physical and sexual abuse.

#### The Ministry of Defence (British Forces, Germany)

I established a Clinical Psychology mental health service for serving personnel, their dependants and allied civilian professionals. I was the only Clinical Psychologist working for the MoD in Germany serving a catchment population of approximately 50, 000 of whom 38,000 were adults. As well as holding my own case-load I provided supervision and training for other mental health professionals and psychological advice to the military Chain of Command on occupational matters. Much of the work involved addressing familial issues resulting from personnel deployment and screening / treatment for post-traumatic stress.
