I started working as a locum consultant in East London foundation trust from 26th of October 2020. My job was initially based at 2 places Dunstable and Luton cambs. I had 0.5 sessions in both places. Since August 2021, I have moved full time to Luton cambs.

My job plan contains 10 Programmed Activities per week. 7.5 Programmed Activities for Direct Clinical Care duties and 2.5 Programmed Activities for Supporting Professional Activities. I am also participating in out of hours on call rota. It is at present 1:6 on call.

I have been attending and chairing the team meetings regularly. I also attend new patient clinics to help my colleagues with the diagnosis and management of new cases. I am also available in the clinic for colleagues to approach me if they have a difficult case or if they need advice urgently. I regularly see new patients and follow-up patients in my clinic. Due to Covid situation, most of the appointments were either virtual consultation or telephone appointments and we would only see urgent /high-priority cases in clinic. As things are getting back to normal, I have started seeing more patients for face-to-face consultation.

I also attended peer supervision meetings and academic meetings organised by the team and by the trust whenever I am able to attend. I teach medical students and psychiatry trainees whenever the opportunity arises. I am also to chair of peer supervision meeting and manage day duty rota for consultants.
