Such patients frequently require careful management of psychopharmacology alongside psychotherapy and behavioural inputs as well as detailed working with community services to provide on-going support after discharge.

- I have worked extensively with colleagues from other mental health disciplines and agencies to provide assessment, consultation, liaison and treatment for children and teenagers with a history of emotional, physical, sexual abuse and neglect, presenting with traits of PTSD and Emerging Emotionally Unstable Personality Disorder, including self-harm and suicidal behaviour.
- This experience has provided me with a good understanding of the roots of adult personality disorder and the roots of adult substance misuse and co-morbid pathologies.
